Subject to the terms set forth herein, KitchenAid Brand of Whirlpool Corporation (hereafter "KitchenAid") guarantees your new KitchenAid Brand Low Profile Microwave Hood Combination (MHC) featuring the FIT System Limited Guarantee will fit in the same space as your 30" wide under cabinet hood or standard MHC, based on 24" minimum install height from the top of your cooking surface / counter to the bottom of your upper cabinet (top of the cutout), or KitchenAid will refund the full purchase price. Finance charges, any costs incurred in connection with the removal of your previous hood or microwave and cost of delivery and installation of the qualifying KitchenAid microwave are not covered by this Fit System Guarantee.

The Fit System Limited Guarantee covers replacement installations in your existing cabinet and is not valid for new cabinet installations related to new home construction or remodeling. KitchenAid makes no other guarantees as to the proper fit of your new KitchenAid Brand Low Profile Microwave Hood Combination (MHC) other than as set forth herein.

2) **WITHIN 90 DAYS** of the purchase or delivery date (whichever is later), mail the following documents to the address provided by the Fit System Limited Guarantee Service Representative:

- i) This completed and signed claim form;
- ii) a legible copy of your sales receipt dated between 9/1/24-12/31/25 and proof of the delivery date, if utilizing the delivery date to calculate the 30/90-day claim periods;
- iii) a photograph of the existing model that is being replaced

Retain a copy of all documents for your records. Allow 8 weeks from the date your claim form is mailed for delivery of claim payment. Complete the contact, model and purchase information below. **NOTE: All fields must be completed to process your claim.**
